1. All the petitions are taken up together for final disposal being similar.
2. A report has been received from the learned District & Sessions Judge, Faridabad in which it has been stated that in different cases there are total 182 applications under Section 36(2) of the Arbitration and Conciliation Act, 1996 (hereinafter referred to as 'the Act') pending in District Court, Faridabad and 78 applications instituted in the year 2019 have been fixed for consideration/arguments and the Presiding Officer has been sensitized to expedite the disposal of such pending applications by putting sincere efforts.
