SANJAY VASHISTH, J.

1. Present petition has been filed under Articles 226 and 227 of the Constitution of India, seeking protection of the life and liberty of the petitioner and her sons from the wrongful and vindictive actions of the local police of Phillaur and Goraya, District Jalandhar. The police, without any prima facie evidence and with the sole motive of fulfilling their targets, have been repeatedly registering false FIRs/Kalandras against the petitioner and her sons.

2. On asking of Court, Status report by way of affidavit of Sarwan Singh Bal, PPS, Deputy Superintendent of Police, Sub Division Phillaur, Jalandhar (Rural) has been filed in Court by learned State counsel in Court today. Same is taken on record. Registry is directed to tag the same at appropriate place with the paper-book.

3. Perusal of the status report reveals that paragraph No. 5 describes the cases registered against the petitioner, which reads as under:
