By way of present petition filed under Section 482 of BNS, 2023, petitioner seeks anticipatory bail in case FIR as under:

2. Learned counsel for the petitioner submits that in compliance to the order dated 08.05.2025 passed by this Court, the petitioner has already joined the investigation and as such prayed for confirming the interim bail granted vide order dated 08.05.2025.

3. Learned State counsel intimates the Court that the petitioner has joined investigation and is neither required for further investigation nor for any custodial interrogation.

4. During the course of hearing on 08.05.2025, following order was passed:

*“ 2. It is, inter alia, contended by learned counsel for*

*the petitioner that the petitioner is innocent and has been falsely implicated in this case on account of party faction. He contends that no specific overt act is attributed to the petitioner and even as per the allegations only simple injury is allegedly attributed to the petitioner.*

*3. Learned counsel for the petitioner further contends that in the meanwhile, with the intervention of respectables a compromise has been effected between the parties and has placed on record the copy of compromise (Annexure P-2). He further contends that the petitioner has no criminal antecedents and is ready to join the investigation.*

*4. Notice of motion.*

*5. On the asking of the Court, Mr. Jatinderpal Singh, Sr. DAG, Punjab, present in Court, accepts notice on behalf of the State-respondent and has not disputed the factual matrix. Learned State counsel has specifically mentioned on the basis of pairvi report that simple injury is attributed to the petitioner as per the allegations.*

*6. Mr. Vishavjeet Singh Rishi, Advocate has put in appearance on behalf of the complainant and has filed his memo of appearance. The same is taken on record. He has admitted to the factum of compromise (Annexure P-2) having been effected between the parties voluntarily. He further submits that he has specific instructions from the complainant victim to say that he has no objection in grant of bail to the petitioner as the matter stood compromised.*

*7. Be it the case, without commenting on the merits, the petitioner is hereby directed to join investigation within seven days from today and in the event of his arrest, he is ordered to be released on interim bail on his furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating*

*Officer. He shall also abide by conditions as envisaged under Section 482(2) of BNSS.*

*8. List on 23.05.2025. ”*

5. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 08.05.2025 passed by this Court, interim bail granted vide order dated 08.05.2025 is hereby confirmed, subject to conditions as envisaged under Section 482 (2) of BNSS, 2023. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; he will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.

6. The petition stands allowed.

7. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
