1. Factual background:-

1.1 With the consent of the learned counsel representing the parties, a batch of 283 connected review applications (detail whereof is attached at the foot of this judgment) shall stand disposed of by a common order.

1.2 The landowners seek review of the judgment passed on 17.08.2015 while assessing the market value of the acquired land under 3 different notifications issued under Section 4 of the Land Acquisition Act, 1894 (hereinafter referred to as '1894 Act') on 23.12.1999, 01.01.2001. The market value was assessed as under:-

1.3 The judgment of the High Court was challenged in the Supreme Court but was permitted to be withdrawn with the following order passed on 11.01.2016:-

“Permission to file Special Leave Petitions is granted.

Delay in filing the Special Leave Petitions and the applications for substitution is condoned.

Applications for substitution are allowed.

Learned counsel for the petitioners, on instructions, seeks permission of this Court to withdraw these Special Leave Petition with liberty to file Review Petitions before the High Court.

Permission sought for is granted.

The Special Leave Petition are disposed of as withdrawn with liberty to the petitioners to approach this Court again to challenge the impugned order as well as the order to be passed in the review petition by the High Court if so required.”

1.4 The review applications were dismissed by the High Court on 06.05.2016. In fresh round at the behest of landowners, the Supreme Court on 13.04.2017 passed the following order:-

“Heard the learned counsel for the petitioners.

Delay condoned.

We have perused the order passed in review by the High Court.

In view of the order dated 11.01.2016 passed by this Court, the High Court, in our considered opinion, ought to have taken into account the grounds urged in the review application (s) filed by the Special Leave Petitioners and consider the same.

As the order passed in the review does not disclose any of the grounds urged, we request the High Court to consider the said grounds and pass a reasoned order.

Special Leave Petitions are disposed of in the above terms.”

2. Arguments put forth by learned counsel representing the parties:-

2.1 Heard the learned counsel representing the parties at length and with their able assistance perused the paperbook. Some of the learned counsel representing the review applicants have also filed their written notes of submissions.

2.2 The main argument of the learned counsel representing the review applicants is that the Court has erred in ignoring the market value assessed as on 29.08.1998 @ Rs.20,37,532/- per acre by the High Court in **UT, Chandigarh vs. Behal Singh Gill and others** (RFA-2989-2006 decided on 18.5.2010) with respect to acquisition of land in village Dadumajra. The petitioners claim that the market value of the acquired land vide notification dated 23.2.1999, 01.01.2001 and 23.11.2003 should have been assessed by granting suitable enhancement, minimum at the rate 12%



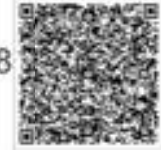

per annum. They also rely upon the market value of the acquired land as on 27.10.1986 at the rate of Rs.91,80,000/- per acre in **Vijay Kumar Bansal vs. UT, Chd.** (RFA-3495-2013 decided on 16.10.2015). Same was the position of 29.19 acres of land in village Maloya, which was sought to be acquired vide notification dated 08.01.2007. Similarly, reliance is also placed with respect to market value assessed of 167.55 acres of land in village Maloya. In this case again, the market value as on 27.09.2006(the date of notification under Section 4) was assessed at Rs.91,80,000/-.

2.3 Per contra, learned counsel representing the UT, Chandigarh has submitted that the scope of jurisdiction while deciding the review application is limited and the acquired land of village Dadumajra, which is situated at a sufficient distance from villages Dhanas, Maloya and Sarangpur cannot be relied upon for assessing the market value of the acquired land in this case. It is further contended that market value assessed in the judgment in **Behal Singh Gill's case (supra)** has already been taken into consideration by the Court hence, there is no ground to review.

3. Analysis and Discussion:-

3.1 The scope of review in the matter of assessment of the market value of the acquired land is not larger than the review of the judgment as envisaged under Section 114 read with Order XLVII of the Code of Civil Procedure, 1908 (hereinafter referred to as 'CPC'). Section 114 CPC enables the Court to review the judgment or order whereas Order XLVII lays down the following grounds of review:-

“i) Discovery of new and important matter or evidence which after exercise of due diligence was not within the knowledge of the review applicant or could not be produced by him when the decree was passed or order was made.

ii) If the judgment suffers from some error or mistake apparent on the face of record.

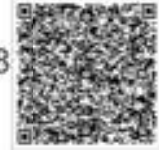
iii) If there are any other sufficient reasons to review the order.”

3.2 The Hon’ble Supreme Court in series of judgments have consistently held that under the garb of review, rehearing of the matter is not permissible.

3.3. Reliance in this regard can be placed on **Shri Ram Sahu (Dead) through legal representatives and others vs. Vinod Kumar Rawat and others (2021) 13 SCC 1**. The relevant paras are reproduced below:-

8. The dictionary meaning of the word “review” is “the act of looking, offer something again with a view to correction or improvement”. It cannot be denied that the review is the creation of a statute. In Patel Narshi Thakershi v. Pradyumansinghji Arjunsinghji [Patel Narshi Thakershi v. Pradyumansinghji Arjunsinghji, (1971) 3 SCC 844] , this Court has held that the power of review is not an inherent power. It must be conferred by law either specifically or by necessary implication. The review is also not an appeal in disguise.

9. What can be said to be an error apparent on the face of the proceedings has been dealt with and considered by this Court in T.C. Basappa v. T. Nagappa [T.C. Basappa v. T. Nagappa, AIR 1954 SC 440] . It is held that

section imposed any prohibition on the court for exercising its power to review its decision. However, an order can be reviewed by a court only on the prescribed grounds mentioned in Order 47 Rule 1CPC, which has been elaborately discussed hereinabove. An application for review is more restricted than that of an appeal and the court of review has limited jurisdiction as to the definite limit mentioned in Order 47 Rule 1CPC itself. The powers of review cannot be exercised as an inherent power nor can an appellate power be exercised in the guise of power of review.”

3.4 Learned counsel representing the review applicants do not dispute that the judgment passed in **Behal Singh Gill’s case (supra)** was considered and distinguished by the Court while passing judgment on 17.08.2015. It was observed that the acquired land located in village Dadumajra is not comparable with the acquired land in villages Dhanas, Lahora and Sarangpur. This Court has also examined the layout plan produced by counsel representing UT, Chandigarh. On its careful perusal, it becomes evident that village Dadumajra is located at a sufficient distance from Dhanas, Lahora and Sarangpur. Village Dadumajra is near Sector 38 West, which is part of the sectoral plan of the City, whereas Village Lahora, Sarangpur and Dhanas are behind Panjab University (Sector 14) and Post Graduate Institute of Medical Education and Research, Chandigarh (Sector 12). These three villages are not part of the sectoral plan of Chandigarh City. Hence, this Court does not find it appropriate to rely upon **Behal Singh Gill’s case (supra)** to assess the market value of the acquired land.

3.5 **Vijay Kumar Bansal's case (supra)** is also with respect to land located in Village Dadumajra. Hence, the acquired land of Village Dadumajra is not comparable with the acquired land in this case located in Villages Dhanas, Lohara and Sarangpur. Similarly, village Maloya abuts village Dadumajra and is at a far off place from the acquired land in the present case. **Gurpreet Singh's case** also pertains to village Maloya.

3.6 It has also been submitted by the learned counsel representing the review applicants that there is a restriction on utilization of the land for commercial or residential purpose under the Chandigarh Administration by promulgation of the Capital of Punjab (Development and Regulation) Act, 1952, Punjab New Capital (Periphery) Control Act, 1952 and Punjab Scheduled Roads and Controlled Areas (Restrictions of Unregulated Development) Act, 1963, hence, the assessment of the market value of agricultural land is not appropriate. It may be noted here that these Acts are universally applicable to the territory of Chandigarh in order to ensure regulated development. Hence, this cannot be treated as a ground for review.

3.7 In the review application, the reliance is also placed on assessment of market value of the acquired land located in Village Kachheri, Badheri and Palsora. A bare look at the layout shows that village Palsora and Kachheri and Badheri are located on the north-western side of the city whereas the acquired land is on the north-eastern side.

4. Decision:-

4.1 In view of the aforesaid discussion, finding no merit, all the review applications are dismissed.

4.2 All the pending miscellaneous applications, if any, are also disposed of.
