In the present writ petition, the petitioner is praying for quashing of the impugned orders dated 25.06.2019 (Annexure P-1), 25.06.2019 (Annexure P-2), 11.10.2021 (Annexure P-3), 22.10.2021 (Annexure P-4), 26.10.2021 (Annexure P-4A), 30.11.2021 (Annexure P-5) and 25.09.2019 (Annexure P-6) issued by respondent No.3 whereby, a fact finding enquiry for ascertaining the role of the petitioner has been ordered.

2. Learned counsel for the petitioner submits that the issue involved in the present writ petition is duly covered by the judgment passed

by a co-ordinate Bench of this Court in case titled as **Punjab State Warehousing Corporation Field Employees Union versus Union of India and others**, CWP No.27725 of 2013 and other connected petitions, decided on 14.05.2025. However, he submits that a perusal of the aforesaid order would reflect that the liberty has been granted to the petitioners therein, to submit the representation, which will be considered by the concerned authority in terms of the order passed by the Court.
