- i) Present application has been filed under Section 528 of BNSS, seeking impleadment of applicant-Kashmir Kaur through General Power of Attorney Holder Sukhdev Singh as party-respondent No.3.
- ii) At the very outset, learned counsel for the applicant prays for withdrawal of the present application with liberty to avail remedy available to him, in accordance with law.
- iii) Dismissed as withdrawn with liberty as sought and recorded hereabove.

i) Present petition has been filed under Section 528 of BNSS, seeking quashing of FIR No. 60 dated 10.06.2022, under Sections 406, 420, 467, 468, 471 and 120-B IPC, registered at Police Station Sector-11, Chandigarh on the basis of compromise effected between the parties on 11.03.2025.

ii) On 27.03.2025, following order was passed:

*“1. At this stage, counsel for the petitioner presses the prayer No.2, whereby quashing of the look out circular has been sought.*

*2. It cannot be left unnoticed the thereupon, petitioner has already been granted the concession of anticipatory bail by this Court, vide order dated 20.03.2025, passed in CRM-M-48438-2024.*

*3. In all likelihood, the operation of the said look out circular no more exists, still, learned Public Prosecutor would confirm the said issue, and thereupon, inform the Court on the next date of hearing .*

*4. List again on 08.04.2025.”*

iii) Thereafter, on 08.04.2025, following order was passed:

*“1. Prayer in the present petition under Section 528 BNSS, is for uashing of FIR No.60 dated 10.06.2022, under Sections 406, 420, 467, 468, 471 and 120-B IPC, registered at Police Station Sector 11, Chandigarh.*

*2. A request for cancellation of look out notice (LOC) has already been approved by the authority, however, finalization of the same is still awaited.*

*3. List again on 07.05.2025.*

*To be shown in the urgent list.”*
