This Criminal Writ Petition under Article 226 for issuance of writ in the nature of mandamus for issuance of direction to official respondents to protect the life and liberty of the petitioner and his family members and to restrain the private respondents not to harass the petitioners.

Learned State Counsel has submitted that a speaking order has already been passed in the representations dated 06.04.2024, 03.07.2024 and 16.04.2025 (Annexures P-1 to P-3) by the authorities concerned and has produced the copy of the same, which is taken on record. He has furnished a copy of the order to counsel for the petitioner. The same is also reproduced below :-

*'Whereas Suraj Bhan S/o Som Nath R/o Mansa Has Moved a Writ Petition Bearing number CRWP-6521/2025 to Protect the Life And Liberty of The Petitioner And His Family From Respondent Raj Kumar S/o Tej Bhan R/e Mansa And His Family Ptitioner Suraj Bhan's Father Som Nath And Raj Kumar Both Are Brothers. Ptitioner's Father Som Nath is The Chairmain Of Shiv Shakti Society Bhikhi And Respondent Raj Kumar is The Secretary Of Shiv Shakti Society Bhikhi. Their is Property Dispute Regarding Shiv Shakti Society Between Both Parties So Both Parties Moved Application Against Each Other. So Keeping In The View of Above Complaints Already Under DDR NO 27 Dated 6.2.2025 U/S 126/170 BNSS Prevention Action Measures Have Been taken, Also The Weapon Of Respondent Raj Kumar Gun 12 Bore NO. 17761-06 Has Already been Submitted in The Naib Gun House Mansa On 25.4.2025 With Receipt No 3624. Petitioner Suraj Bhan Moved a Application NO 249-1-1018/PGD Dated 17.4.2025 Against Raj Kumar S/o Tej Bhan, Mohit Kumar S/o Raj Kumar, Sidhant S/o Raj Kumar to Protect the Life And Liberty of The Petitioner And His Farmiy From them. Regarding This Matter Deepak Kumar S/o Som Nath Had Moved A Application in Honorable Punjab &Haryana Highcourt Chandigarh Bearing Number CRM-M-19584/2025 Against Raj Kumar And ETC. Regarding Which Order Passed By The Honorable Court," " Let the representa\_on dated 21.03.2025 (Annexure P-4) be decided by the concerned Senior Superintendent of Police, by 30.04.2025, either himself/herself or by authorizing and delega\_ng it to any officer holding IPS cadre. It is clarified that such order must be a reasoned order, and the same be communicated to the representa\_onists as well as his counsel without delay."*

*Under The Direction Of honorable Punjab And Haryana High Court Chandigarh Senior Superintendent of Police Mansa By His Office Order No 4901-04/C/Lit Dated 15.4.2025 Formed Special Investigation Team of Superintendent of Police (Investigation) Mansa And Deputy Superintendent of Police SD Mansa To Conduct The Investigation Of Above Matter. During investigation Of SIT TEAM*

*FIR NO 81 Dated 25.4.2025 U/S 316(4) 316(4),318(4),324(4),61(2)  
BNS PS BHIKHI Against Raj Kumar, Mohit Mehta And Tarsame  
Kumar Was registered And Copy of FIR is Attached with The Report.  
Arrest of Accused is Pending Case is Under investigation.'*
