1. The petitioner through instant petition under Articles 226 and 227 of the Constitution of India is seeking direction to respondents to honour deployment letter No.Hkcrn/2024/8/69516 issued to him.

2. The petitioner by vocation is a Driver. He applied for job to Haryana Kaushal Rozgar Nigam Limited (for short 'HKRNL'). He was registered by said Organization and intimated that he has been selected for a contractual job under HKRNL. The said communication has been withdrawn on the ground that due to technical glitch, he was shortlisted and his selection stands cancelled. In future if he is shortlisted for any position then would be informed. The communication was made through official portal. The communication made to petitioner on 16.08.2024 is reproduced as below:

3. The petitioner was not selected against an advertised or sanctioned post. The respondent-HKRNL has been constituted by the State Government to protect the interest of contractual employees. The said Organization is providing job opportunities as an outsource manpower agency.

4. This Court does not find that by impugned communication any fundamental or vested right of the petitioner has been violated. The Court is sanguine of the fact that respondent- HKRNL would consider claim of petitioner as and when there are job opportunities.

5. Dismissed.
