**KIRTI SINGH, J. (ORAL)**

1. The present petition has been filed under Section 528 BNSS, 2023, for the issuance of directions upon the respondents by calling the status report upon the investigation conducted so far in FIR No. 285 dated 22.12.2024 under Sections 140(3) and 70(1) of BNS, registered at P.S. Mamdot (Annexure P-1).
2. Status report by way of affidavit of Deputy Superintendent of Police (Rural) Ferozepur, District Ferozepur, has been filed by the State, which is taken on record. Relying upon the same, it is submitted that the petitioner had friendly relations with accused Sukhchain Singh son of Tarsem Singh and on 20.12.2024, at about 1.00 A.M, she at her own volition left her house with Sukhchain Singh and returned back to her house at 2.50 A.M. Therefore, the allegations with regard to abduction of the petitioner or committing rape upon her could not be made out. Moreover, it has also been submitted therein that a cancellation report has been prepared and the same shall be presented in the Court concerned after completion of requisite formalities.



3. The relevant paragraph of the status report reads as under:-

*“7. That during investigation of the case, one application no. 552369-UID dated 18.03.2025 was filed by Salwinder Singh son of Kartar Singh for false implication of the accused in this case. The said application was marked for enquiry and report to SP(Inv) Ferozepur and after enquiry SP(Inv) Ferozepur submitted his report no.82R/SP(Inv) dated 12.05.2025 and during enquiry, it was found that the petitioner had friendly relations with Sukhchain Singh son of Tarsem Singh accused, who is also residing in his village. Thus, on 20.12.2024 at about 1.00 AM, she left of her own from her house with Sukhchain Singh and after spending time with him, returned back to her house at 2.50 AM. This fact also verified from the pen drive and CCTV footages produced by Salwinder Singh, in which the petitioner was seen by foot with Sukhchain Singh in the street at about 1:00:20 AM and returned back to her house from the street of Sukhchain Singh at 2:59:04 AM. Thus no facts came into picture with regard to abduction of petitioner or committed rape with her. The said report was duly approved by Senior Superintendent of Police, Ferozepur on 27.06.2025”*

4. In view of the above, no directions are required to be passed.

5. The petition stands dismissed as such.

6. Pending miscellaneous application(s), if any, also stands disposed of.
