Arbitration Case No. 188 of 2015 (O&M)

This is an application under section 11 of the Arbitration & Conciliation Act, 1996 for appointment of a sole Arbitrator to adjudicate upon the disputes and differences between the parties.

2. The respondents did not deny the existence of the arbitration agreement. They, however, sought to file reply on the merits of the matter. The merits of the dispute are not relevant. It is, therefore, not necessary to grant them to file reply on the merits of the dispute.

3. It is agreed by the parties that the claims and counter-claims shall stand referred to the arbitration.

4. As the arbitration agreement is admitted, the petition is disposed of by appointing Mr. Justice Permod Kohli, a former Judge of this Court, as a sole Arbitrator to adjudicate upon the disputes and differences between the parties. The fee of the arbitrator shall be as per the Arbitration Rules framed by this Court subject ofcourse to the same being acceptable to the learned Arbitrator.
