Accordingly, we **dispose of** this case with a direction to the Insurance Company to deposit a crossed-cheque for ₹3,00,000/- in the name of the appellant - Gurmeet Singh son of Sh.Sahib Singh with the office of the Lok Adalat of the High Court within 60 days, in compliance of this order, failing which, interest @ 9% per annum shall follow on this amount from the date of this order till payment. The concerned Officer of the Lok Adalat Branch/Office shall issue proper receipt after receiving the cheque to learned counsel/representative of the respondent-Insurance Company. The appellant(s)' counsel/appellant(s) may collect the cheque from the office of the Lok Adalat.

All pending application(s), if any, shall stand closed.

Copy of the order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
