**HARSH BUNGER J. (ORAL)**

1. Petition herein is, *inter alia*, for issuance of a writ under Articles 226/227 of the Constitution of India to direct the respondents to restrain them to not disconnect the connections for supply of tubewell connections running on 24 hours in the absence of the policy from AP Urban Feeder to AP Rural Feeder, and restraining the respondents from transferring the power connection of petitioners from Urban Feeder, Patti Sub Division (Tarn Taran) to rural feeder or any other feeder, which are being used by the petitioners to run their tubewells for irrigation purposes from the last number of years.
2. Learned counsel for the petitioner, at the outset, submits that the petitioners have served legal notice dated 11.09.2024 (Annexure P-6) upon respondents; however, the same has not been adverted to by the concerned



authority, till date. Learned counsel further submits that the petitioner would be satisfied at this stage, in case a time bound direction is issued to respondent No.3 – Sub Divisional Officer, PSPCL, City Patti, Tarn Taran, to consider and decide the aforesaid legal notice dated 11.09.2024 (Annexure P-6).

3. On advance service of copy of petition, Mr. Navneet Singh, Sr. DAG, Punjab, appears on behalf of the respondents and opposes issuance of notice of motion. He further submits that respondent No.3 – Sub Divisional Officer, PSPCL, City Patti, Tarn Taran shall take decision either way, on the pending legal notice dated 11.09.2024 (Annexure P-6) within a period of two months from today.

4. Keeping in view the submissions made by learned counsel for the parties and without commenting on the merits of the case, the present writ petition is disposed of with a direction to the respondent No.3 – Sub Divisional Officer, PSPCL, City Patti, Tarn Taran to consider and decide legal notice dated 11.09.2024 (Annexure P-6) by way of passing a speaking order, after affording due opportunity of hearing to all the concerned parties, within a period of two months from today.

5. All pending application(s), if any, shall also stand closed.
