1. Learned counsel for the appellant/petitioner prays to withdraw this appeal as well as writ petition, with liberty to pursue an application for transfer of recognition to a deemed university.
2. Sh. Anupam Gupta, learned senior counsel for the respondents disputes the entitlement of the appellant/petitioner to seek such transfer.
