HARSIMRAN SINGH SETHI J. (ORAL)

1. Present bunch of six writ petitions involve the common question of law in the background of common set of facts and thus they are being decided by a common order.

2. Learned counsel for the petitioner submits that the respondent No.2-workmen has not come forward despite service and best efforts, he has not been served in these petitions.

3. Learned counsel for the petitioner further submits that even as of now, no execution of the impugned award dated 17.08.2016 (Annexure P-1) has been filed by the respondent No.2-workmen hence, the present petitions are disposed of with the observations that as respondent-employee has chosen not to appear and has also not taken any step to get the impugned order implemented, no order is required to be passed in these petitions with liberty to the petitioner to revive the same in case, the respondent No.2 files an execution so as to execute the impugned award so
