The petitioner has filed the instant petition under Section 482 of the BNSS, 2023 for grant of pre-arrest bail to the petitioner in case bearing FIR No. 281 dated 20.06.2025, under Sections 318 (4) & 319 of BNS and Section 66-C and 66-D of the IT Act, registered at Police Station City Bhiwani.

Learned counsel for the petitioner *inter alia* contends that pursuant to the order dated 25.07.2025 passed by this Court, the petitioner has joined investigation and is no longer required for investigation of the case.

Learned State counsel on instruction from concerned Investigating Officer, corroborates the said averment and submits that the custodial interrogation of the petitioner is not required for the purpose of investigation.

Heard learned counsel for the parties.

Since the petitioner has joined the investigation and his custodial interrogation is not required, the present petition is allowed and the interim order dated 25.07.2025 is made absolute.

However, if required, the petitioner shall continue to join investigation as and when required to do so and shall abide by the terms and conditions, as laid down under Section 482 (2) BNSS.
