AWARD OF LOK ADALAT BENCH NO.4

On 12.12.2024, the following order was passed:

“It is stated by the counsel for the appellants that in case an amount of Rs.6 lacs is paid over and above the amount already awarded by the Tribunal, this appeal can be settled. He has signed the proposal sheet.

Counsel for the respondent-Insurance Company seeks time to get instructions.

Adjourned to 09.01.2025.”

The respondent-Insurance Company has agreed to accept the proposal made. Proposal sheet has been signed by the representative of the Insurance Company. A perusal of the file indicates that the Insurance Company’s liability is only to the extent of 50% and remaining 50% is to be borne by respondents No.2 and 3. Respondent No.2 is wrongly mentioned as respondent No.3 in the memo of parties. Learned counsel for the appellants states that so far as liability of respondent No.2-owner is concerned, he will be satisfied with the amount

paid by the Insurance Company. He also said so in his statement separately.

As agreed, (statements of learned counsel for the appellant as well as counsel for the Insurance Company, separately recorded) a sum of Rs.6,00,000/- (Rupees Six lacs only), over and above, the amount already awarded by the Tribunal is allowed to the appellants in full and final settlement of the claim.

Learned counsel for the appellants stated that agreed amount be released in favour of appellant No.1-Jasbir Kaur. It was further undertaken that in case in future any claim is raised by any other claimant-appellant(s), the appellant No.1-Jasbir Kaur shall indemnify the said claimant(s).

Accordingly, we dispose of this case with a direction to the respondent-Insurance Company to deposit cheque of Rs.6,00,000/- (Rupees Six lacs only) in favour of the appellant No.1-Jasbir Kaur with the office of the Lok Adalat of the High Court on or before 12.03.2025. Failing compliance of the order, interest @ 9% per annum shall follow on this amount till payment from the date of this order. The appellant's counsel may collect the cheque from the office of the Lok Adalat after retaining the photocopy of the cheque/draft bearing signatures of the Counsel.
