Reply dated 09.01.2025, filed in the form of affidavit of Assistant Commissioner of Police, Traffic I, Faridabad, , on behalf of State-respondent, is taken on record. Copy thereof has been supplied to learned counsel for the petitioner.

2. By way of present petition filed under Section 482 of the Bharatiya Nagarik Suraksha Sanhita 2023 (BNSS), the petitioner seeks anticipatory bail in case FIR (Annexure P-1) as under: -

3. Learned counsel for the petitioner submits that in compliance to the order dated 05.12.2024, the petitioner have joined the investigation.



4. During the course of hearing on 05.12.2024, following order has been passed: -

*'2. It is, inter alia, contended by learned counsel for the petitioner that the petitioner is innocent and has been falsely implicated in this case just with a view to harass the petitioner in connivance with the police. He contends that the allegation against the petitioner is that she had visited the house of the complainant during night hours. He contends that the petitioner is living in the same premises and it was diwali night and there was no illegality done by the petitioner nor the amount was transferred as alleged because the same could not have been done without the knowledge of pin for UPI transaction. He contends that the complainant is habitual of giving fictitious complaints to the police. Hence, the instant petition.*

*3. Notice of motion.*

*4. On the asking of the Court, Mr. Ramender Singh Chauhan, AAG, Haryana, present in Court, accepts notice on behalf of the State-respondent and prays for time to file the status report/reply in the matter.*

*5. Adjourned to 15.01.2025.*

*6. Needful be done well before the date fixed with an advance copy to the counsel opposite.*

*7. In the meanwhile, the petitioner is hereby directed to join investigation within seven days from today and in the event of her arrest, she is ordered to be released on interim bail on her furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. She shall also abide by conditions as envisaged under Section 482(2) of the Bharatiya Nagarik Suraksha Sanhita 2023 (BNSS).'*

5. Learned State counsel on instructions received from the H.C. Parveen, informs the Court that the petitioner has joined the investigation and is neither required for further investigation nor for any custodial interrogation.

6. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 05.12.2024 passed by this Court, interim bail granted vide order dated 05.12.2024 is hereby confirmed, subject to conditions as envisaged under Section 482(2) of the Bharatiya Nagarik Suraksha Sanhita 2023 (BNSS). Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; she will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.

7. The petition stands allowed.

8. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
