Prayer in the present revision petition is for issuing direction to the ld. Civil Judge (Jr. Divn.), UT Chandigarh to decide the application dated 03.2.2024 (Annexure P-4) filed by the petitioner seeking permission/clarification to float tender for providing “in-building wireless solution” in the upcoming buildings in PGIMER, in a time bound manner.

Brief facts are that the plaintiff/respondent had filed a suit for mandatory injunction and perpetual injunction seeking compensation on account of loss/damages. In the said suit, vide order dated 09.12.2021 (Annexure P3) passed by the learned Civil Judge application of the respondent under Order 39 Rules 1 and 2 CPC was allowed and the petitioner was restrained from carrying on proceedings arising out of tender notice dated 28.09.2021 floated by it for attracting bids for the work pertaining to ‘In Building Wireless Solutions’ during the pendency of the suit.



It is *inter alia* submitted by learned counsel for the petitioner/defendant that the petitioner had filed an application dated 3.2.2024 (Annexure P-4) before the learned Civil Judge (Jr. Divn.), Chandigarh seeking clarification of the said order dated 9.12.2021. It is submitted that clarification is required that the petitioner be allowed to float fresh tenders in respect of the other/new buildings which are not subject matter of the suit tender. It is submitted that as the application of the petitioner is pending since 3.2. 2024, a direction be issued to the learned Civil Judge (Jr. Divn.), Chandigarh to decide the same expeditiously. Learned counsel informs that the next date fixed before the trial Court is 20.09.2025.

Heard.

After hearing learned counsel for the petitioner, issuance of notice of motion is dispensed with at this stage, as it will only cause further delay in disposal of the case.

Since the application for clarification (Annexure P-4) is pending before the learned Civil Judge (Jr. Divn.), Chandigarh since 3.2.2024 i.e. for a period of almost 1-½ years, the present petition is **allowed**; and the learned trial Court is directed to decide the application dated 03.2.2024 (Annexure P-4) within a period of two months from the next date of hearing fixed before it i.e. 20.9.2025.

Pending application(s), if any, shall stand disposed of.
