1. CWP Nos. 4391 and 18138 of 2023 are taken up together for hearing and adjudication at request and with consent of learned counsel for parties as both these petitions arise out of communications dated 23.09.2022 and 13.01.2023, Annexures P-3 and P-4.
2. CWP No. 4391 of 2023 has been filed by petitioner Ankit Sapra in his individual capacity and CWP No. 18138 of 2023 has been filed by the M/s AMP Integrated Facility Management Private Limited through its director, namely Ankit Sapra.
3. Prayer in both writ petitions is for quashing of same communications dated 23.09.2022 and 13.01.2023, Annexures P-3 and P-4, whereby provisional attachment of bank accounts of petitioner and other business entities has been directed.
4. It is pointed out that order dated 22.02.2023 was passed by Additional Director General of Goods and Service Tax Intelligence, Gurugram Zonal Unit, whereby request for de-attachment of the accounts has been declined. The said order was admittedly, an appealable order.
5. Learned senior counsel for petitioner (in CWP No. 4391 of 2023) submits that he has been unable to contact the petitioner and has no instructions as to whether an appeal has been filed.

6. Learned counsel for respondent-Department is also unable to inform whether the appeal has been filed.

7. Learned senior counsel for petitioner (in CWP No. 4391 of 2023) submits that he does not have any instructions to appear in CWP No. 18138 of 2023.

8. It appears that the petitioner(s) are not interested in pursuing the matter any longer.

9. Accordingly, CWP No. 4391 of 2023 is dismissed for non-prosecution and CWP no.18138 of 2023 is dismissed in default and for non-prosecution. Pending application(s), if any, stand(s) disposed of accordingly.
