The jurisdiction of this Court has been invoked under Article 226 of the Constitution of India for directing the official respondents No.2 & 3 to protect the life and liberty of the petitioners from the hands of respondents no.4 to 9.

2. Status report has been filed today in Court, which is taken on record.

3. Leaned State counsel submits that in compliance of the order dated 04.02.2025 passed by this Court, the petitioners were provided the protection through a Constable/gunman on shift basis and after the deputation of such police official, petitioner-Ravneet Kaur has come forward to record their statements, which read as under:

*:It is stated that I am a resident of abovesaid address and on 29-01-2025, I have solemnized marriage with Indergiri s/o Prem Lal resident of Jonewal, Ludhiana at Pracheen Prabhupati Mandir, Panchkula, Haryana at my own will. In this regard, I have solemnized marriage on 4-2-25 at Hon'ble Punjab and*



*Haryana High Court, Chandigarh. In this regard, we both husband wife apprehend danger to our life from our parents Sukhwinder Singh, Mother Dalijinder Kaur, brother Jaskaran Singh, Uncle (Chacha) Bhupinder Singh, Uncle's son Gurpreet Singh and Massi son Arshdeep Singh but now there is no danger to our life from these persons. You along with police officials have visited our house for our security but now there is no need of security for us. We both the husband and wife want to live life peacefully in the house and I don't want to get initiated any action against my parents and brother, sisters. I have got recorded my statement with you in the presence of below mentioned respectable persons and heard the same which is Correct.”*

4. In pursuance thereof, GD No. 012 dated 05.02.2025 at 15:25 hrs has been registered.

5. From the bare perusal of the statement, it is evident that now the petitioners do not have any danger to their lives at the hands of the private respondents and they do not wish to proceed with the instant petition and wants to withdraw the same.

6. Prayer is accepted.

7. Dismissed as withdrawn.
