1. The present two regular second appeals arise out of a commercial dispute between the parties.

2. The judgment debtor as at present the decree holder have joined the proceedings through VC and with the interaction of the Court have agreed that the matter be resolved and the decree holder is ready to pay an amount of Rs.20,00,000/- (Rupees Twenty Lakhs only) in lump sum towards full and final settlement of all the claims. Accordingly, the present regular second appears are decided in light of the settlement arrived at between the parties.

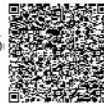
3. Without going into the merits, the learned counsel for the appellants- M/s M & S Restaurant Private Ltd. and Ors on instructions of Mr. Manmohan Singh Chaddha, Director has submitted that the appellants are ready to remit a sum of Rs.20,00,000/- (Rupees Twenty Lakhs only) to the respondent through RTGS and the counsel for the decree holder has shared the Bank details which are as under:

Sona Madhavprasad Mantri

4. It has been agreed that the said amount be remitted within 15 days from today, however, it would be appreciated if the same be done within 10 days.

5. It is made clear that this would be full and final settlement and none of the parties will raise any claim or counter-claim *qua* the same.

6. The execution petition filed by the decree holder shall be kept in abeyance for 15 days and the moment settlement amount as agreed upon

is remitted by the judgment-debtor, the execution petition shall be disposed of as fully satisfied.

7. Mr. Mukand Gupta, Advocate also at this stage, submits that as and when the settlement amount would be received the execution shall be withdrawn as fully satisfied.

8. It is made clear that the proof of remittance of the amount would be sufficient for the Executing Court to put the proceedings at rest and the decree holders' presence will not be pressed upon.

9. In case, the parties do not abide by this settlement arrived at, the parties will be at liberty to move an appropriate application for revival of the appeals and the interim protection granted to the judgment-debtor with regard to attachment of account shall be revisited.
