that to ensure that complete justice is done to the present petitioner, therebys the show cause notice (Annexure P-7), has been at this stage, rather profoundly contemplated to be withdrawn.

2. Prayer accepted.
3. Consequently, the writ petition at this stage is accepted.
4. However, respondent No. 2 is directed to ensure that after granting all opportunities to the present petitioner, thus the Enrollment Committee of the Bar Council of the Punjab and Haryana, thus shall undertake the fresh exercise of re-appreciating the enrollment application of the petitioner, but reiteratedly after granting all opportunities to the present petitioner to produce evidence to justify that he has acquired the apposite valid qualification.
5. The afore decision shall be taken within a period of three months from today.
6. The petitioner is directed to make his first appearance before the Enrollment Committee of the Bar Council of Punjab and Haryana, on 16.05.2025.
7. Disposed of accordingly alongwith all pending applications, if any.
