2. Prayer in the application (CM-12471-C-2024) filed under
Order XXIII Rule 3 CPC read with Section 151 CPC, is for disposal of
the main appeal in terms of compromise deed dated 13.10.2023
(Annexure A-3).

Learned counsel for the applicant-appellants submits that the entire disputes which are the subject matter of this second appeal stand settled between the parties by way of compromise deed dated 13.10.2023 (Annexure C-1). It is, accordingly, prayed that the present second appeal may be disposed of in terms of aforesaid compromise arrived at between the parties.

4. Learned counsel for respondent No. 1(i) and 1(ii) has not disputed the factum of compromise between the parties and submits that he has 'no objection' in case the application is allowed and the main second appeal is disposed of in terms of compromise (Annexure C-1).

5. In view of the above, the application (CM-12471-C-2024) is allowed and the main second appeal bearing RSA-4492-2016 is **disposed of** in terms of compromise 13.10.2023 (Annexure C-1) effected between the parties.

6. Decree-sheet be prepared in terms of compromise dated 13.10.2023 (Annexure C-1) arrived at between the parties.

7. It is needless to say that both the parties shall abide by the terms and conditions of the aforesaid compromise (Annexure R-1).
