**PANKAJ JAIN, J. (Oral)**

The claimants seeks re-assessment of compensation on account of injuries suffered by him in a motor vehicular accident. The Tribunal, while assessing compensation, observed as under : -

*“20. The petitioner has led in evidence bills, cash memos of purchase of medicines prescribed for his treatment Ex.P-2 to P-25 of Rs.9000/- approximately. Further as is deposed by PW-1 Om Parkash, he remained on leave without pay for four months and 20 days and thereby suffered a loss of Rs.3000/- per month total amounting to Rs.14000/- on this account. In addition, he also would be entitled for compensation on account of pain and suffering etc. and incidental expenses like travelling expenses etc. which in the circumstances are assessed at Rs.8000/- in all.”*

2. The compensation awarded by the Tribunal is substituted as under :-

3. With the aforesaid modification, the impugned award is modified. The appeal is disposed off. Keeping in view the observations made on issue No.7, it is ordered that the amount shall be paid to the claimants by the insurance company who shall be further entitled to recover the same from the insured. The enhanced amount shall also bear interest as awarded by the Tribunal.

4. Pending application, if any, stands disposed off.
