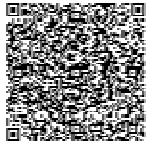

1. By way of this order, we dispose of these two connected LPAs which have been preferred by the appellant assailing order dated 14.03.2022 passed by the learned Single Bench in CWPs No.11941 & 10103 of 2017.

2. Written request for an adjournment, circulated on behalf of the learned arguing counsel for the appellant, is rejected.

3. We have taken up this case whereby learned Single Bench relied on the judgment dated 26.08.2013 passed by the learned Single Bench in CWP No. 1881 of 2012 titled as **Smt. Shashi** Vs. **DHBVNL and others**. It seems that with the purpose to cover up the present LPA preferred



against order dated 14.03.2022, an appeal was filed against the judgment dated 26.08.2013 passed in the case of Smt. Shashi (Supra).

4. We have already dismissed the LPA preferred against the judgment passed in the case of Smt. Shashi (Supra) today. Accordingly, since the learned Single Bench has followed the judgment of Smt. Shashi (Supra) which has been upheld by us, the present LPAs are also dismissed and the stay granted by this Court in these cases vide order dated 03.03.2023 stands vacated.

5. All pending applications in these cases are disposed of accordingly.
