1. The instant writ petition has been filed for issuance of directions to respondent No.6 to allot the stations and to allow the petitioners to join their respective duties after having been selected under Group-‘D’ under the ESP category.

2. Learned counsel appearing on behalf of the petitioners contends that the petitioners were recommended by the Haryana Staff Selection Commission for the Group ‘D’ posts under the ESP category. He contends that the sports gradation certificates issued by the Department of Sports had been submitted by them with the authorities for verification. He contends that even though the petitioners have been recommended and allotted the office of Registrar, Cooperative Societies, Haryana vide recommendation dated 12.03.2024, however, despite lapse of more than one year, the petitioners are not being allowed to join on the ground that the verification of the sports gradation certificates is still awaited. He contends that he would be satisfied in case the respondent-authorities are directed to submit a



verification report about the sports gradation certificates of the petitioners in a time bound manner and a further direction be issued to respondent No.6-Registrar, Cooperative Societies, Haryana to issue the appointment to the petitioners on receipt of such verification of sports gradation certificates. He contends that a legal notice dated 17.04.2025 has already been served upon the respondents.

3. Notice of motion.

4. Mr. Tapan Kumar, DAG Haryana, accepts notice on behalf of respondent(s)-State and submits that she has no objection to the aforesaid prayer being granted.

5. With the consent of the parties, the present petition is accordingly **disposed of** without commenting on the merits of the present case and with a direction to respondent No.7-District Sports and Youth Affairs Officer, Charkhi Dadri and respondent No.8- District Sports and Youth Affairs Officer, Rohtak, to send the verification report(s) of the sports gradation certificates of the petitioners to respondent No.6-Registrar, Cooperative Societies, Haryana within a period of 02 months of receipt of a certified copy of this order. Respondent No.6 is directed to issue the appointment order in favour of the petitioners, in case the verification report is received in their favour, within a further period of 01 month.
