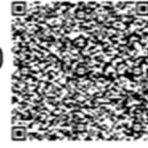
MAHABIR SINGH SINDHU, J.

Present petition has been filed under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (*for short 'BNSS'*) read with Section 528 of the BNSS for grant of interim regular bail to the petitioner in FIR No.11 dated 12.04.2022, under Sections 18, 25 & 29 of the Narcotic Drugs and Psychotropic Substances Act, 1985, registered at Police Station State Special Operation Cell (SSOC), Amritsar, for a period of 10 days to attend the marriage of his real daughter.

(2) This Court, while issuing notice of motion on 20.02.2025, passed the following order:-

“Petition under Section 483 of the Bhartiya Nagarik Suraksha Sanhita, 2023 (for short, 'BNSS') for grant of interim bail to petitioner-Sukhdev Singh in FIR No.11 dated 12.04.2022, under Sections 18, 25, 29 of Narcotic Drugs & Psychotropic Substances Act, 1985, registered at Police Station

State Special Operation Cell, Amritsar, for a period of 10 days to attend the marriage of his real daughter.

2. *Notice of motion.*

3. *Mr. Kunwarbir Singh, AAG, Punjab, learned State Counsel accepts notice on behalf of the respondent-State and on instructions from Inspector Inderdeep Singh, has apprised the Court that marriage of real daughter of petitioner, namely, Kirandeep Kaur is going to be solemnized on 22.02.2025.*

4. *Keeping in view the urgency involved, petitioner is ordered to be released on interim bail forthwith for a period of one week w.e.f. 20.02.2025 to 27.02.2025, on his furnishing bail/surety bonds to the satisfaction of learned Special Court/Duty Magistrate concerned.*

He shall surrender before Jail Authorities on 28.02.2025 at 11.00 a.m.

(3) Today, it is acknowledged by both sides that petitioner has surrendered before the Jail Authorities on 28.02.2025 after availing the concession of aforesaid interim bail.

(4) In view of the above, present petition is disposed off.
