Status report dated 14.02.2025 in the form of an affidavit of Deputy Superintendent of Police, Ellenabad, District Sirsa, has been filed. The same is taken on record. Copy thereof has been supplied to learned counsel for the petitioner.

2. By way of present petition filed under Section 438 Cr.P.C, the petitioner seeks anticipatory bail in case FIR (Annexure P-1) as under: -

3. Learned counsel for the petitioner submits that in compliance to the order dated 27.01.2025, the petitioner has joined the investigation.



4. During the course of hearing on 27.01.2025, following order had been passed: -

“ 2. It is, *inter alia*, contended by learned counsel for the petitioner that the petitioner having no criminal antecedents has been falsely implicated in this case. She contends that the petitioner happens to be the bona fide purchaser of the tractor in question, having made payment thereof to the co-accused, namely Braham Pal, a broker, as is evident from Bank Statement (Annexure P-5), having made payment of about Rs. 7.00 lakhs to him.

3. Learned counsel for the petitioner further contends that in the Registration Certificate (Annexure P-4) of the truck in question, there was no mention of any hypothication to the complainant and the petitioner had bona fidely purchased the same. She contends that the said broker, Braham Pal had since been arrested and granted concession of bail. Hence, the instant petition

4. Notice of motion.

5. On the asking of the Court, Mr. Praveen Bhadu AAG, Haryana, present in Court, accepts notice on behalf of the Staterespondent and prays for time to file the status report/reply in the matter.

6. Adjourned to 15.02.2025.

7. Needful be done well before the date fixed with an advance copy to the counsel opposite.

8. In the meanwhile, the petitioner is hereby directed to join investigation within seven days from today and in the event of his arrest, he is ordered to be released on interim bail on his furnishing personal/surety bonds to the satisfaction of the Arresting Officer/Investigating Officer. He shall also abide by conditions as envisaged under Section 482(2) of the Bharatiya Nagarik Suraksha Sanhita 2023 (BNSs).

9. Investigating Officer (concerned) to remain present in Court along with relevant records on the date fixed.”

5. Learned State counsel on instructions received from S.I. Surinder informs the Court that the petitioner has joined the investigation



and is neither required for further investigation nor for any custodial interrogation.

6. Keeping in view the above submissions made by learned State counsel and the fact that the petitioner had joined the investigation consequent to the order dated 27.01.2025 passed by this Court, interim bail granted vide order dated 27.01.2025 is hereby confirmed, subject to conditions as envisaged under Section 482(2) of BNSS. Further the petitioner is directed to join investigation as and when required in future by way of written notice for such purpose to be served by Investigating Officer of this case upon the petitioner; he will not tamper with the evidence nor will influence the witnesses and will not leave the country without prior permission of the Court.

7. The petition stands allowed.

8. It is made clear that anything contained hereinabove shall not be construed to be an expression of opinion on the merits of the case.
