The present petition has been filed under Article 226 of the Constitution of India with a prayer to issuance of a writ in the nature of habeas corpus, directing the official respondents to get the alleged detinue, namely, Ms. Neha released from the illegal custody of respondent No.4.

In compliance of the order dated 03.07.2025 passed by this Court, respondent No.3 has produced Ms. Neha (alleged detinue) before this Court.

I have interacted with the alleged detinue, who states that at present she is residing with her father, i.e. respondent No.4, voluntarily and out of her own free will. Since the alleged detinue is major, she is permitted to go to a place of her choice.

In view of the statement made by the alleged detinue, no further orders are required to be passed. Accordingly, the present petition stands disposed of.
