1. As common issues are involved in the captioned petitions, the same are hereby disposed of by this common order. For the sake of

brevity and convenience, facts are borrowed from **CR-4943-2025**.

2. On 30.07.2025, following order was passed by this Court:-

*“Learned counsel appearing on behalf of the petitioner submitted that an application under Section 36(2) of the Arbitration and Conciliation Act, 1996 as well as objection petition under Section 34 of the Arbitration and Conciliation Act, 1996 is pending before the learned Additional District Judge, Palwal since 08.08.2019 but even the application for stay has not been adjudicated upon. He submitted that his limited prayer is seeking a direction to the concerned Court to decide the same expeditiously.*

*Before proceeding further, let a status report be called from the concerned Additional District Judge, Palwal with regard to the status of the case.*

*Adjourned to 11.09.2025.”*

3. Learned counsel for the petitioner submits that grievance of the petitioner stands redressed, thus, instant petitions have rendered infructuous. He may be allowed to withdraw all the petitions.

4. Dismissed as withdrawn.
