NAMIT KUMAR, J. (ORAL)

1. Present petition has been filed under Section 401 Cr.PC impugning the order dated 22.12.2017 passed by learned Additional Principal Judge, Family Court, Rohtak, whereby respondents No.1 to 3 have been granted maintenance of a sum of Rs.8,000/- per month to them.

2. On the last date of hearing, the following order was passed:-

“The matter was referred to the Mediation and Conciliation Center of this Court vide order dated 09.09.2024.

The Mediator has submitted his report dated 24.09.2024, wherein it has been stated as under :-

“6 (e) xx xx xx xx The second party-Pinky is present with her son-Vinay in the Mediation Centre today, however, her daughter-Nidhi is not present today. Pinky-second party says that she is giving statement on behalf of her daughter also that she is agreeable to all the terms and conditions of the present



settlement/agreement and she will be present in the Hon'ble High Court to record her statement, if needed, on the date when the case is listed in the Hon'ble High Court i.e. 15.01.2025. In case the case is preponed for any other date, then she will be present on that date in the Hon'ble High Court."

However, Ms.Nidhi, daughter of the petitioner is not present in the Court today.

Learned counsel for the respondents shall produce Ms.Nidhi on the next date of hearing.

Adjourned to 03.02.2025."

3. Ms. Nidhi, daughter of the petitioner, is present in Court and has submitted that she has no objection to the terms and conditions of the compromise dated 24.09.2024.
4. Learned counsel for the parties are *ad idem* that the matter has been settled between the parties in terms of settlement dated 24.09.2024 and the present petition may be disposed of in terms of the compromise.
5. Disposed of in terms of the settlement dated 24.09.2024 arrived at between the parties. However, parties shall be bound by the terms and conditions of the said settlement.
6. Pending application(s), if any, also stand disposed of.
